Launched in 2013 amid an era of unprecedented change, the Nashville Health Care Council Fellows is an annual five-month program aimed at helping senior health care leaders **define complex problems; identify solutions through collaboration; and foster leadership skills.** The national program is co-led by former **U.S. Senate Majority Leader Bill Frist, M.D.**, and Vanderbilt Owen Graduate School of Management **Professor Larry Van Horn.**

Through eight full-day sessions, Fellows participate in a rigorous curriculum with in-depth discussions around key leadership topics such as:


- » Consumerism

- » Employed by a health care organization of any size in multiple sectors, including providers, managed care, technology, public health, government, academia, nonprofit, policy, communications, legal or finance among others.

- » Endorsed by two industry leaders (through two letters of referral), including the CEO of their organization.
- » Commitment to attend eight full-day sessions in Nashville in late Winter and Spring.
- » Office is based anywhere in the United States.
